**PURCHASER AGREES TO THE FOLLOWING:**

1. The kitten will not be sold to anyone else without the approval of the seller.
2. The kitten/cat is to be kept strictly indoors or the health guarantee will be void.
3. Purchaser has read the Ragdolls Reign Kitten Information Document. Please initial to confirm \_\_\_\_\_

**HEALTH AND OTHER GUARANTEES:**

1. If buyer takes kitten to their vet within 72 hours to confirm health of the kitten and their vet puts in writing that they do not have a healthy kitten, buyer should return the kitten at buyer's expense immediately to receive a refund. (Note that kittens may develop a minor cold or eye infection due to the stress of transitioning.)
2. The seller guarantees kitten against any serious genetic defects such as heart, kidney or liver for a period of 4 years from birth as well as 2 years from birth from FIP fatality. **Illness must be veterinarian confirmed/certified Pathologist must furnish an autopsy.** Tests and/or autopsy at buyer's expense. If death occurs, seller will furnish buyer with a replacement kitten of equal quality as soon as possible. If the ragdoll does not die, health issues may be worked out monetarily between the buyer and the seller.
3. **DO NOT administer more than one vaccine at a time or the health guarantee will be void.**
4. The seller shall not be liable for any medical expenses i.e. tests, medications or treatments for any health condition. Pet insurance is an option to consider.
5. Guarantees are not given for allergies, personal dislikes or litter training. However, if these occur or if any type of problem or concerns are suspected, contact the seller immediately so that the situation can be discussed, and a solution found. Immediate action on any problem is necessary.
6. **Never use flea collars. Never allow your vet to give the FIP vaccine (Feline Infectious Peritonitis). Leukemia vaccine is not necessary for indoor cats.**
7. **The litter is registered with The International Cat Association. Registration documentation will be provided.**
